 for an animal, including risks of injury to person and property, and that I have voluntarily agreed to make the
 adoption contemplated herein with full knowledge of such risks and hereby voluntarily assume all of such risks.
- 1 agree that I will not make any claims against, sue or attach any property of The. Enchanted Poodle Club, Inc., its directors, officers, agents, employees and/or volunteers for any caused injury or damage by any animal adopted from The Enchanted Poodle
- 3 Club, Inc.I hereby voluntarily release, discharge, waive and relinquish any and all actions or causes of action for personal injury, property damage or wrongful death occurring to me or third parties as a result of any action or activity of any animal adopted by me from The Enchanted Poodle Club, Inc. . It is my intention by this instrument to exempt and relieve The Enchanted Poodle Club, Inc. from ALL liability for personal injury, property damage or wrongful death caused by negligence of otherwise.
